- Students Enrolment (Class VIII):

We acknowledge the change in the number of sections in Class VIII, which now stands at one section. Our Application for CBSE Affiliation was submitted in 2022, when there were three sections running in Class VIII. But now new session (2023-24) has been started and the Students of Class VIII were promoted to class 9th and there are two sections currently running in class IX. And that's why we currently have 1 section in Class VIII and this is the reason why IC members mentioned the same in IC Report.

- Water & Sanitation Certificate:

We have obtained the renewal certificate for water and sanitation and will promptly update this information in our Mandatory Public Disclosure. A copy of the certificate will also be sent to [cbse.aff@nic.in](mailto:cbse.aff@nic.in).

- Land Certificate:

We intend to apply for the Land Certificate in the new CBSE format (Appendix-X) within the next two working days. Upon receiving the certificate (expected within a month), we will notify CBSE and update the mandatory disclosure on our school website accordingly.

- Fire Safety Certificate:

Our school building has undergone a modification from G+3 to G+4 storeys since the issuance of our previous Fire Safety Certificate. We are in the process of obtaining a new certificate with the correct updated information and will inform CBSE within a month. We will also update this certificate on our school website's mandatory disclosure.

- Safety Measures in Composite Labs:


We wish to clarify that our school already adheres to safety measures in our composite lab. We have installed two doors, exhaust fans, and fire extinguishers in our lab facilities.


- Sitting Arrangement in Library:
